1. Taxe inscriere (rezervarea locului in scoala)

1.1. Taxa de inscriere - 250 Euro

- se achita inainte de semnarea contractului, la depunerea Formularului de Inscriere (Anexa 5), in termen de 5 zile calendaristice de la data emiterii facturii.
- taxa este platibila o singura data si acopera costurile evaluarii si procesarii documentelor pentru procesul de admitere;
- taxa este returnata in cazul in care se refuza inscrierea in scoala.

1.2 Depozit de inscriere - 1.500 Euro

- reprezinta rezervarea locului in scoala si se achita in termen de 5 zile calendaristice de la data emiterii facturii, dupa semnarea contractului, dupa parcurgerea procesului de admitere in BIST;
- depozitul de inscriere se deduce din taxa scolara anuala, respectiv din ultima rata/rate in cazul modalitatilor de plata trimestriale/lunare.

1. Enrolment fees (securing a place in school)

1.1. Registration fee - 250 Euro

- it is paid before signing the contract, while submitting the signed Enrolment Form Appendix #5, and is due within 5 days from invoice date ;
- It is a one-off payment and it covers the costs for processing the documents and the administrative costs part of the admission process;
- the fee is refunded if the admission file is not eligible.

1.2 Enrolment deposit - 1500 Euro

- represents the reservation of the place in the school and is paid upon signing the contract after the admission process in the BIST; the fee is due within 5 days from invoice date;
- the enrolment deposit is deducted from the annual school fee, namely from the last instalment when choosing an instalment payment method.

Taxa de scolarizare include:

- 2.1. Programele educationale oferite in timpul anului scolar conform calendarului academic 2019-2020 (Anexa 3) si orarului scolar de luni pana vineri intre orele 8.30 – 16.00;
- 2.2. Materialele educationale inclusiv manualele scolare, caietele si toate rechizitele necesare activitatii la clasa;
- 2.3. Taxe de examinare platibile catre board-ul de examinare din Marea Britanie (Cambridge) pentru anul 6 de studiu (tarifele sunt estimative si pot fi modificate de catre board-ul de examinare din Marea Britanie): sfarsitul anului 6 – Engleza si Matematica – 17 EUR / materie;
- 2.4. Accesul la toate facilitatile scolii in timpul zilei si in timpul anului scolar;
- 2.5. Cluburile scolare desfasurate in timpul zilei de scoala;
- 2.6. Doua excursii locale pe an, cu durata de maxim o zi, desfasurate pe parcursul unei zile.

3. Taxa de scolarizare nu include:

- 3.1. Uniforma scolara - trebuie achizitionata de la scoala inainte de inceperea anului scolar; costul uniformei va fi comunicat parintilor (purtarea uniformei scolare este obligatorie conform regulamentelor si procedurilor interne, vezi Anexa 4);
- 3.2. Masa de pranz - costul se va negocia cu furnizorii si va fi comunicat parintilor. Alternativ, copiii pot aduce propria hrana pe care o pot servi in cadrul scolii;
- 3.3. Programele after school derulate in intervalul orar 16.30 - 18.00 (optional);
- 3.4. Excursiile si taberele (optional);
- 3.5. Transportul catre si de la scoala (optional);
- 3.6. Taxe de examinare platibile catre board-ul de examinare din Marea Britanie (Cambridge) pentru anii de studii 9, 11 si 13 (tarifele sunt estimative si pot fi modificate de catre board-ul de examinare din Marea Britanie), dupa cum urmeaza:
 - Sfarsitul anului 9 – Engleza, Matematica si Stiinte – 25 EUR / materie
 - Sfarsitul anului 11 – toate materiile studiate – 65 EUR / materie
 - Sfarsitul anului 13 – toate materiile studiate – 100 EUR / materie.

4. Metode de plata

Plata taxei scolare se poate face prin una din urmatoarele modalitati:

- 4.1. **Plata integrala** pentru un an academic sau in avans pentru 3 ani academici – factura se emite in data de 9 august 2019 si are termen de plata 31 august 2019.

The school fee includes:

- 2.1. School programme offered during the school year as stated in the school calendar (Annexe 3) and the academic timetable from Monday to Friday between 8.30 – 16.00;
- 2.2. Educational material including text books, note books and all other materials needed in the classroom;
- 2.3. Examination fees payable to UK examination board (Cambridge) for Years 6 (these fees are for guidance purpose only and can be modified by the UK examination board) as follows: end of Year 6 – English and Maths – 17 EUR / subject;
- 2.4. Full access to all school facilities during the school hours and during the school academic year;
- 2.5. School clubs during the school day;
- 2.6. Two local educational trips a year of maximum 1 day.

3. The school fee does not include:

- 3.1. School uniform must be acquired from the school before the school year starts; the cost will be communicated to parents (wearing the school uniform is compulsory as specified in the school policies and procedures, see Appendix 4);
- 3.2. School lunch – the cost will be negotiated with the providers and will be communicated to parents. Alternatively, children can bring their own meals from home;
- 3.3. After school clubs running between 16.30 - 18.00 (optional);
- 3.4. Trips and camps (optional);
- 3.5. Transportation (optional);
- 3.6. Examination fees payable to UK examination board (Cambridge) for Years 9, 11 and 13 (these fees are for guidance purpose only and can be modified by the UK examination board) as stated below:
 - End of Year 9 – English, Maths and Science – 25 EUR / subject
 - End of Year 11 – all subjects studied – 65 EUR / subject
 - End of Year 13 – all subjects studied – 100 EUR / subject.

4. Payment methods

School fee payment can be made by choosing one of the methods below:

- 4.1. **Full payment** for one academic year or in advance for 3 academic years – the invoice is issued on August 9th 2019, and is due on August 31, 2019.



4.2. **Plata in trei transe egale:**

- 4.2.1. Trimestrul 1 (Septembrie – Decembrie 2019) – factura se emite in data de 9 august 2019 si are termen de plata 31 august 2019;
- 4.2.2. Trimestrul 2 (Ianuarie – Martie 2020) – factura se emite in data de 9 decembrie 2019 si are termen de plata 31 decembrie 2019;
- 4.2.3. Trimestrul 3 (Aprilie – Iunie 2020) – factura se emite in data de 9 martie 2020 si are termen de plata 31 martie 2020.

- 4.3. **Plata lunara in 10 transe egale** – factura se emite in avans pentru luna urmatoare, in intervalul 1-10 al fiecarei luni si este scadenta in urmatoarele 10 zile lucratoare. Astfel, prima factura este emisa in intervalul 1-10 august 2019 in avans pentru luna septembrie 2019 si este scadenta in urmatoarele 10 zile lucratoare, respectiv la 23 august 2019.

5. Reduceri

- 5.1. Reducerile se aplica doar pentru elevii care sunt inscrisi pentru intregul an scolar si sunt oferite in masura in care platile se efectueaza cu respectarea termenului contractual.
- 5.2. O reducere de 3% se aplica pentru plata integrala pentru un an academic; factura se emite in data de 9 august 2019 si are termen de plata 31 august 2019.
- 5.3. O reducere de 5% din taxa cumulata se aplica pentru inscrierea in scoala a mai multor frati/surori, daca plata este efectuata in termenul contractual.

6. Modificari

- 6.1. Orice eventuală schimbare referitoare la taxele pentru următorul an școlar (2020 - 2021) va fi anunțată cel mai târziu în data de 15 februarie 2020.

4.2. **Payment in three equal instalments:**

- 4.2.1. 1st Term (September – December, 2019) – the invoice is issued on August 9th 2019, and is due on August 31, 2019;
- 4.2.2. 2nd Term (January – March, 2020) – the invoice is issued on December 9th 2019, and is due on December 31, 2019;
- 4.2.3. 3rd Term (April – June, 2020) – the invoice is issued on March 9th 2020, and is due on March 31, 2020.

- 4.3. **Monthly payment in 10 equal instalments** – the invoice is issued in advance for the following month, between 1-10 of each month, and is due within the next 10 business days. The first invoice is issued between 1 and 10 August, 2019 in advance for September, 2019, and is due within the next 10 business days, namely on August 23rd, 2019.

5. Discounts

- 5.1. Discounts apply only for students enrolled for a full school year and are offered as long as the school fees are paid with no delays as agreed in the contract.
- 5.2. A 3% discount is offered for full-payment of the one year's fee; the invoice is issued on August 9th 2019, and is due on August 31, 2019.
- 5.3. A 5% discount from the cumulated school fee is offered for more brothers / sisters registered in the school.

6. Changes

- 6.1. Any possible change in the annual school fees for the next academic year (2020 - 2021) will be announced by February 15, 2020.
